**Title:** Legal and Ethical Dilemmas Surrounding Documentation



Ron Chupp, LCSW, LCAC, NCAC-II, ICAC-II has worked in the Mental Health and Addictions profession since 1991, earning his BSW from Goshen College in 1993 and his MSW from IU in 2005. He was licensed as a Clinical Social Worker in 2009 and as a Clinical Addiction Counselor in 2010. He is a Licensed Outpatient Therapist at Bowen Center in Albion, Indiana. Ron was President of IAAP from 2010 to 2012. He chaired the ICAADA Ethics Committee from 2001 to 2004, where he was responsible for revising the ICAADA

*Code of Ethics*, and the IAAP Ethics Committee from 2005 to 2010, where he composed the IAAP *Code of Ethics*. Ron currently chairs the NAADAC Bylaws Committee and is a member of the NAADAC Ethics Committee, where he currently undergoing a revision of the NAADAC *Code of Ethics*. Ron has given numerous presentations on Ethics to addictions counselors and students throughout Indiana including the History and Development of Ethics, Ethical Traditions, Personal and Professional Ethics, Ethical Dilemmas, and Ethics and the Law.

## Workshop Description:

Training will deal with a variety of ethical dilemmas and issues, but our main focus will be legal and ethical issues surrounding documentation. We will examine how to document high risk situations and client behaviors, including what you should and what you should not include in your session notes. We will provide time for discussion on documenting Clinical Supervision sessions as well. We will examine the legal and ethical ramifications of inadequate documentation, and methods for avoiding unintended consequences. Come prepared with your questions and examples to process with your colleagues and instructor.
