Indiana Wesleyan University's North Education Center is in the Precedent Office Park between I-465 and 96th Street, just east of Keystone Ave. on the north side of Indianapolis. 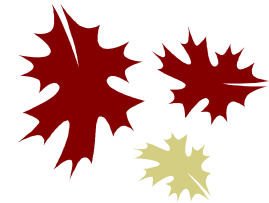

Friday Speaker

Stephanie L. Lusk, Ph.D., CRC, is currently an Assistant Professor at the University of Arkansas where she teaches courses in the both the Master's and Doctoral Rehabilitation Counseling Program. She earned a doctorate in Rehabilitation Education and Research and a Master's in Rehabilitation Counseling from Arkansas State University. Her prior work experiences include career development and placement, transition planning, and substance abuse treatment. Dr. Lusk's other experiences include the design and implementation of the Rehabilitation Counseling and Behavioral Addictions certificate program at North Carolina A&T State University. She has created a curriculum/training program designed to support the licensure and certification of individuals seeking addictions credentials for the Substance Abuse and Mental Health Services Administration (SAMHSA). Dr. Lusk is the recipient of over \$2 million in grant funding from the Department of Education/Rehabilitation Services Administration, SAMHSA, and the Center for International Rehabilitation Research and Information Exchange (CIRRIE). She has conducted over 20 local, national, and international presentations throughout the course of her career. Published works include articles in the *Journal of Vocational Rehabilitation Counseling*, the *Online Journal of Workforce Development* and numerous textbook chapters on opioid, cocaine, and alcohol addictions as well as supervision, multicultural issues, co-occurring disorders, and treatment. Her primary areas of research include substance abuse treatment and co-occurring disabilities among African American women. Dr. Lusk is also the current President of the Institute for the Advancement of Working Families.

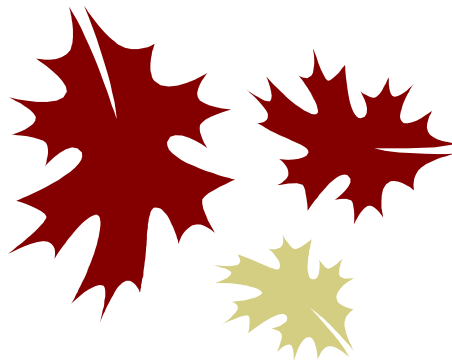
